

The Beatles Story Ltd Gift Voucher Terms and Conditions

- 1. There are 3 types of Gift Voucher available for purchase at beatlesstory.com: Admission Gift Vouchers, Cafe Gift Vouchers and Shop Gift Vouchers.
- 2. All Gift Vouchers can only be purchased online at beatlesstory.com and cannot be purchased at our sites. Please see below our site addresses.
- 3. Beatles Story Admission Gift Vouchers are valid for general admission to The Beatles Story only, at our Royal Albert Dock site. These can be purchased as a 2 Adult Gift Ticket or a Family Gift Ticket (2 adult and 2 child admissions at a discounted rate). If our admission prices change you will be charged the difference upon redemption of your voucher. Admissions Gift Vouchers can only be redeemed online at beatlesstory.com.
- 4. Beatles Story Cafe Gift Vouchers are valid for use against purchases at our Fab4 Cafes at both our Royal Albert Dock and Pier Head sites. These are redeemable at the monitory value as stated on your voucher and are available to purchase at £10 or £20 at a time.
- 5. Beatles Story Shop Gift Vouchers are valid for use against purchases at our Fab4 Stores at both our Royal Albert Dock and Pier Head sites. These are redeemable at the monitory value as stated on your voucher and are available to purchase in increments of £10 starting at £10 up to £50 at a time.
- 6. Purchased gift vouchers will be sent to the email address entered by the customer at time of purchase, which may be the customer or chosen recipient as specified by the customer on purchase.
- 7. Beatles Story Café and Shop Gift Vouchers can be used as payment against one transaction, or for multiple transactions, if it has a remaining balance.
